# A journey through resource control lambda calculi and explicit substitution using intersection types

#### Abstract

In this paper we invite the reader to a journey through three lambda calculi with resource control: the lambda calculus, the sequent lambda calculus, and the lambda calculus with explicit substitution. All three calculi enable explicit control of resources due to the presence of weakening and contraction operators. Along this journey, we propose intersection type assignment systems for all three resource control calculi. We recognise the need for three kinds of variables all requiring different kinds of intersection types. Our main contribution is the characterisation of strong normalisation of reductions in all three calculi, using the techniques of reducibility, head subject expansion, a combination of well-orders and suitable embeddings of terms.


Keywords: lambda calculus, resource control, sequent calculus, explicit substitution, intersection types, strong normalisation, typeability

## Introduction

It is well known that simply typed $\lambda$-calculus captures the computational content of intuitionistic natural deduction through Curry-Howard correspondence [35]. This connection between logic and computation can be extended to other calculi and logical systems [30]: Herbelin's $\bar{\lambda}$-calculus [34], Pinto and Dyckhoff's $\lambda \pi \sigma$ calculus [51] and Espírito Santo's $\lambda^{\mathrm{Gtz}}$-calculus [21] correspond to intuitionistic sequent calculus. In the realm of classical logic, Parigot's $\lambda \mu$-calculus [50] cor-

[^0]responds to classical natural deduction, whereas Barbanera and Berardi's symmetric calculus [4] and Curien and Herbelin's $\bar{\lambda} \mu \widetilde{\mu}$-calculus [15] correspond to its sequent version. Extending first, the $\lambda \times$ calculus of explicit substitution and later $\lambda$-calculus and $\lambda^{\mathrm{Gtz}}$-calculus with explicit operators for erasure (a.k.a. weakening) and duplication (a.k.a. contraction) brings the same correspondence to intuitionistic natural deduction and intuitionistic sequent calculus with explicit structural rules of weakening and contraction on the logical side [25], as investigated in [36, 37, 28].

On the other hand, let us consider type assignment systems for various calculi. To overcome the limitations of the simple type discipline in which the only forming operator is an arrow $\rightarrow$, a new type forming operator $\cap$ was introduced in $[13,14,52,57]$. The newly obtained intersection type assignment systems enabled complete characterisation of termination of term calculi [3, 24, 26]. The extension of Curry-Howard correspondence to other formalisms brought the need for intersection types into many different settings [19, 40, 44, 47].

Our work is inspired by and extends Kesner and Lengrand's [36] work on resource operators for $\lambda$-calculus with explicit substitution. Their linear $\lambda \mid x r-$ calculus introduces operators for linear substitution, erasure and duplication, preserving at the same time confluence and full composition of explicit substitutions of its predecessor $\lambda \times[9,54]$. The simply typed version of this calculus corresponds to the intuitionistic fragment of Linear Logic's proof-nets, according to Curry-Howard correspondence, and it enjoys strong normalisation and subject reduction. Resource control in sequent $\lambda$-calculus was proposed by Ghilezan et al. in [28], whereas resource control both in $\lambda$-calculus and $\lambda x$-calculus was further developed in [37, 38].

In order to control all resources, in the spirit of $\lambda I$-calculus (see e.g. [5]), void lambda abstraction is not acceptable, so in order to have $\lambda x . M$ the variable $x$ has to occur in $M$. But if $x$ is not used in a term $M$, one can perform an erasure (a.k.a weakening) by using the expression $x \odot M$. In this way, the term $M$ does not contain the variable $x$, but the term $x \odot M$ does. Similarly, a variable should not occur twice. If nevertheless, we want to have two positions for the same variable, we have to duplicate it explicitly, using fresh names. This is done by using the operator $x<_{x_{2}}^{x_{1}} M$, called duplication (a.k.a contraction) which creates two fresh variables $x_{1}$ and $x_{2}$.

Explicit control of erasure and duplication leads to decomposing of reduction steps into more atomic steps, thus revealing the details of computation which are usually left implicit. Since erasing and duplicating of (sub)terms essentially changes the structure of a program, it is important to see how this mechanism re-
ally works and to be able to control this part of computation. We chose a direct approach to term calculi rather than taking a more common path through linear logic [1, 8]. In practice, for instance in the description of compilers by rules with binders [55, 56], the implementation of substitutions of linear variables by inlining ${ }^{1}$ is simple and efficient when substitution of duplicated variables requires the cumbersome and time consuming mechanism of pointers and it is therefore important to tightly control duplication. On the other hand, precise control of erasing does not require a garbage collector and prevents memory leaking.

Our main goal is to characterize the termination of reductions for term calculi with explicit control of duplication and erasure, in different frameworks: natural deduction, sequent style and with explicit substitution. We revisit the syntax and reduction rules of three term calculi with explicit operators for weakening and contraction: $\lambda_{\circledR}$ (the extension of the $\lambda$-calculus), $\lambda_{\circledR}^{G \text { tz }}$ (the extension of the sequent lambda calculus $\lambda^{G \mathrm{Gzz}}$ ) and $\lambda_{\circledR}^{\times}$(the extension of the $\lambda x$-calculus with explicit substitution). We then introduce intersection types into all three calculi $\lambda_{\circledR}, \lambda_{\mathbb{®}} \mathrm{Gtz}^{\mathrm{tz}}$ and $\lambda_{\mathbb{®}}^{\times}$. Our intersection type assignment systems $\lambda_{\mathbb{B}} \cap \lambda_{\mathbb{R}} \mathrm{Gtz}^{\mathrm{G}} \cap$ and $\lambda_{\mathbb{R}}^{\times} \cap$ integrate intersection into logical rules, thus preserving syntax-directedness of the system. We assign restricted form of intersection types to terms, namely strict types, therefore minimizing the need for pre-order on types. By using these intersection type assignment systems we prove that terms in all three calculi enjoy strong normalisation if and only if they are typeable. To the best of our knowledge, together with the conference version of this paper [27], this is the first treatment of intersection types in the presence of resource control operators. Intersection types fit naturally to resource control. Indeed, the control allows us to consider three types of variables: variables as placeholders (the traditional view of $\lambda$-calculus), variables to be duplicated and variables to be erased because they are irrelevant. For each kind of a variable, there is a kind of type associated to it, namely a strict type for a placeholder, an intersection for a variable to-be-duplicated, and a specific type for an erased variable.

We first prove in Section 1 that terms typeable in $\lambda_{\circledR}$-calculus are strongly normalising by adapting the reducibility method for explicit resource control operators. Then we prove that all strongly normalising terms are typeable in $\lambda_{®^{-}}$ calculus by using typeability of normal forms and head subject expansion.

Further, we prove strong normalisation for $\lambda_{\mathbb{®}}^{\mathrm{Gtz}}$ and $\lambda_{\mathbb{R}}^{\times}$, in Section 2 and

[^1]Section 3, respectively, by using a combination of well-orders and a suitable embeddings of $\lambda_{\mathbb{\circledR}}^{\mathrm{Gtz}}$-terms and $\lambda_{\mathbb{\circledR}}^{\times}$-terms into $\lambda_{\circledR}$-terms which preserve typeability and enable the simulation of all reductions and equations by the operational semantics of the $\lambda_{\mathbb{R}}$-calculus. Finally, we prove that strong normalisation implies typeability in $\lambda_{\circledR}^{\mathrm{Gtz}}$ and $\lambda_{\circledR}^{\times}$using head subject expansion.

Related work. The idea to control the use of variables can be traced back to Church's $\lambda I$-calculus [5]. Currently there are several different lines of research in resource aware term calculi. Van Oostrom [48] and later Kesner and Lengrand [36], applying ideas from linear logic [32], proposed to extend the $\lambda$-calculus and the $\lambda x$-calculus, with operators to control the use of variables (resources). Generalising this approach, Kesner and Renaud [37, 38] developed the prismoid of resources, a system of eight calculi parametric over the explicit and implicit treatment of substitution, erasure and duplication. Resource control in sequent calculus corresponding to classical logic was proposed in [62]. On the other hand, process calculi and their relation to $\lambda$-calculus by Boudol [10] initialised investigations in resource aware non-deterministic $\lambda$-calculus with multiplicities and a generalised notion of application [11]. The theory was connected to linear logic via differential $\lambda$-calculus in [20] and typed with non-idempotent intersection types in [49]. In this paper we follow the notation of [62] and [27], which is related to [48].

This paper is an extended and revised version of [27]. In addition to $\lambda_{\circledR}-$ calculus and $\lambda_{\mathbb{B} \text { (zz }}$-calculus presented in [27], this extended version adds the treatment of the $\lambda_{\circledR}^{\circledR}$-calculus, the resource lambda calculus with explicit substitution, together with the characterization of strong normalisation for this calculus. Also, the proof that typeability implies strong normalisation in $\lambda_{\circledR}$-calculus is improved.

Outline of the paper. In Section 1 we first give the syntax and reduction rules for $\lambda_{\circledR}$-calculus, followed by the intersection type assignment system and the characterisation of strong normalisation. Section 2 deals with $\lambda_{\circledR}^{G \text { tz }}$-calculus, its syntax, reduction rules, intersection type assignment system and the characterisation of strong normalisation. Section 3 introduces $\lambda_{\mathbb{\circledR}}^{\times}$-calculus with its syntax, reduction rules and intersection type assignment system, again followed by the characterisation of strong normalisation. Finally, we conclude in Section 4 with some directions for future work.

## 1. Intersection types for the resource control lambda calculus $\lambda_{\circledR}$

In this section we focus on the resource control lambda calculus $\lambda_{\circledR}$. First we revisit its syntax and operational semantics; further we introduce intersection type assignment system and finally we prove that typebility in the proposed system completely characterises the set of strongly normalising $\lambda_{\circledR}$-terms.

### 1.1. Resource control lambda calculus $\lambda_{\circledR}$

The resource control lambda calculus, $\lambda_{\circledR}$, is an extension of the $\lambda$-calculus with explicit operators for weakening and contraction. It corresponds to the $\lambda_{\mathrm{cw}^{-}}$ calculus of Kesner and Renaud, proposed in [37] as a vertex of "the prismoid of resources", where substitution is implicit. We use a notation along the lines of [62] and close to [48]. It is slightly modified w.r.t. [37] in order to emphasize the correspondence between this calculus and its sequent counterpart.

First of all, we introduce the syntactic category of pre-terms of $\lambda_{\circledR}$-calculus given by the following abstract syntax:

where $x$ ranges over a denumerable set of term variables. $\lambda x . f$ is an abstraction, $f f$ is an application, $x \odot f$ is a weakening and $x<_{x_{2}}^{x_{1}} f$ is a contraction. The contraction operator is assumed to be insensitive to the order of the arguments $x_{1}$ and $x_{2}$, i.e. $x<_{x_{2}}^{x_{1}} f=x<_{x_{1}}^{x_{2}} f$.

The set of free variables of a pre-term $f$, denoted by $F v(f)$, is defined as follows:

In $x<_{x_{2}}^{x_{1}} f$, the contraction binds the variables $x_{1}$ and $x_{2}$ in $f$ and introduces a free variable $x$. The operator $x \odot f$ also introduces a free variable $x$. In order to avoid parentheses, we let the scope of all binders extend to the right as much as possible.

The set of $\lambda_{\circledR}$-terms, denoted by $\Lambda_{\circledR}$ and ranged over by $M, N, P, M_{1}, \ldots$. is a subset of the set of pre-terms, defined in Figure 1.

Informally, we say that a term is a pre-term in which in every subterm every free variable occurs exactly once, and every binder binds (exactly one occurrence of) a free variable. Our notion of terms corresponds to the notion of linear terms in [36]. In that sense, only linear expressions are in the focus of our investigation. In other words, terms are well-formed in $\lambda_{\circledR}$ if and only if bound variables appear actually in the term and variables occur at most once. These conditions will be assumed throughout the paper without mentioning them explicitly. This assumption
is not a restriction, since every traditional term has a corresponding $\lambda_{\circledR}$-term, as illustrated by the following example.
Example 1. Pre-terms $\lambda_{x . y}$ and $\lambda_{x}$.xx are not $\lambda_{\circledR}$-terms, on the other hand preterms $\lambda x .(x \odot y)$ and $\lambda x . x<_{x_{2}}^{x_{1}}\left(x_{1} x_{2}\right)$ are their corresponding $\lambda_{\circledR}$-terms.

In the sequel, we use the notation $X \odot M$ for $x_{1} \odot \ldots x_{n} \odot M$ and $X<{ }_{Z}^{Y} M$ for $x_{1}<z_{1}^{y_{1}} \ldots x_{n} \ll_{n}^{y_{n}} M$, where $X, Y$ and $Z$ are lists of size $n$, consisting of all distinct variables $x_{1}, \ldots, x_{n}, y_{1}, \ldots, y_{n}, z_{1}, \ldots, z_{n}$. If $n=0$, i.e., if $X$ is the empty list, then $X \odot M=X<{ }_{Z}^{Y} M=M$. Note that due to the equivalence relation defined in Figure 4, we can use these notations also for sets of variables of the same size.

In what follows we use Barendregt's convention [5] for variables: in the same context a variable cannot be both free and bound. This applies to binders like $\lambda x . M$ which binds $x$ in $M, x<_{x_{2}}^{x_{1}} M$ which binds $x_{1}$ and $x_{2}$ in $M$, and also to the implicit substitution $M[N / x]$ which can be seen as a binder for $x$ in $M$.

The set ${ }^{\circledR}$ of reduction rules $\rightarrow_{\lambda_{\circledR}}$ of the $\lambda_{\circledR}$-calculus is presented in Figure 2.

The reduction rules are divided into four groups. The main computational step is $\beta$ reduction. The group of $(\gamma)$ reductions perform propagation of contraction into the expression. Similarly, $(\omega)$ reductions extract weakening out of expressions. This discipline allows us to optimize the computation by delaying duplication of terms on the one hand, and by performing erasure of terms as soon as possible on the other. Finally, the rules in $(\gamma \omega)$ group explain the interaction between explicit resource operators that are of different nature.

The inductive definition of the meta operator [ / ], representing the implicit substitution of free variables, is given in Figure 3. In order to obtain well formed
terms as the results of substitution, $F v(M) \cap F v(N)=\emptyset$ must hold in this definition. Moreover, notice that for the expression $M[N / x]$ to make sense, $M$ must contain exactly one occurrence of the free variable $x$ and $M$ and $N$ must share no variable but $x .^{2}$ Indeed a substitution is always created by a $\beta$-reduction and, in the term $(\lambda x \cdot M) N, x$ has to appear exactly once in $M$ and the other variables of $F v(M) \cup F v(N)$ as well. Barendregt convention on variable says that $x$ should not occur freely in $N$. Also, if the terms $N_{1}$ and $N_{2}$ are obtained from the term $N$ by renaming all the free variables in $N$ by fresh variables, then $M\left[N_{1} / x_{1}, N_{2} / x_{2}\right]$ denotes a parallel substitution.

Definition 2 (Parallel substitution). $M[N / x, P / z]=(M[N / x])[P / z]$ for $x, z \in F v(M)$ and $(F v(M) \backslash\{x\}) \cap F v(N)=(F v(M) \backslash\{z\}) \cap F v(P)=F v(N) \cap F v(P)=\emptyset$.

In the $\lambda_{\circledR}$-calculus, one works modulo equivalencies given in Figure 4.
Notice that because we work with $\lambda_{\circledR}$ terms, no variable is lost during the computation, which is stated by the following proposition.

Proposition 3. If $M \rightarrow M^{\prime}$ then $F v(M)=F v\left(M^{\prime}\right)$.
Proof. The proof is by case analysis on the reduction rules.
The following lemma explains how to compose implicit substitutions.

## Proof.

### 1.2. Intersection types for $\lambda_{\circledR}$

In this subsection we introduce an intersection type assignment system which assigns strict types to $\lambda_{\circledR}$-terms. Strict types were proposed in [3] and used in [23]
for characterisation of strong normalisation in $\lambda^{\mathrm{Gtz}}$-calculus.
The syntax of types is defined as follows:

where $p$ ranges over a denumerable set of type atoms, and $\cap_{i}^{n} \sigma_{i}$ stands for $\sigma_{1} \cap$ $\ldots \cap \sigma_{n}, n \geq 0$. Particularly, if $n=0$, then $\cap{ }_{i}^{0} \sigma_{i}$ represents the neutral element for the intersection operator, denoted by $T$.
We denote types with $\alpha, \beta, \gamma \ldots$, strict types with $\sigma, \tau, \rho, v \ldots$ and the set of all types by Types. We assume that the intersection operator is idempotent, commutative and associative. We also assume that intersection has priority over the arrow operator. Hence, we will omit parenthesis in expressions like $\left(\cap_{i}^{n} \tau_{i}\right) \rightarrow \sigma$.

## Definition 7.

(i) A basic type assignment is an expression of the form $x$ : $\alpha$, where $x$ is a term variable and $\alpha$ is a type.
(ii) A basis $\Gamma$ is a set $\left\{x_{1}: \alpha_{1}, \ldots, x_{n}: \alpha_{n}\right\}$ of basic type assignments, where all term variables are different. $\operatorname{Dom}(\Gamma)=\left\{x_{1}, \ldots, x_{n}\right\}$. A basis extension $\Gamma, x: \alpha$ denotes the set $\Gamma \cup\{x: \alpha\}$, where $x \notin \operatorname{Dom}(\Gamma)$.
(iii) A bases intersection is defined as:

(iv) $\Gamma^{\top}=\{x: \top \mid x \in \operatorname{Dom}(\Gamma)\}$.

In what follows we assume that the bases intersection has priority over the basis extension, hence the parenthesis in $\Gamma,\left(\Delta_{1} \sqcap \ldots \sqcap \Delta_{n}\right)$ will be omitted. It is easy to show that $\Gamma^{\top} \sqcap \Delta=\Delta$ for arbitrary bases $\Gamma$ and $\Delta$ that can be intersected, hence $\Gamma^{\top}$ can be considered the neutral element for the bases intersection.

The type assignment system $\lambda_{\circledR} \cap$ is given in Figure 5. Notice that in the syntax of $\lambda_{\circledR}$ there are three kinds of variables according to the way they are introduced, namely as a placeholder, as a result of a contraction or as a result of a weakening. Each kind of a variable receives a specific type. Variables as placeholders have a strict type, variables resulting from a contraction have an intersection type and variables resulting from a weakening have a $T$ type. Moreover, notice that intersection types occur only in two inference rules. In the rule (Cont)

the intersection type is created, this being the only place where this happens. This is justified because it corresponds to the duplication of a variable. In other words, the control on the duplication of variables entails the control on the introduction of intersections in building the type of the term in question. In the rule $\left(\rightarrow_{E}\right)$, intersection appears on the right hand side of $\vdash$ sign which corresponds to the usage of the intersection type after it has been created by the rule (Cont) or by the rule (Weak) if $n=0$. In this inference rule, the role of $\Delta_{0}$ should be noticed. It is needed only when $n=0$ to ensure that $N$ has a type, i.e. that $N$ is strongly normalizing. Then, in the bottom of the rule, the types of the free variables of $N$ can be forgotten, hence all the free variables of $N$ receive the type $T$. All the free variables of the term must occur in the environment (see Lemma 8), therefore useless variables occur with the type $T$. If $n$ is not 0 , then $\Delta_{0}$ can be any of the other environments and the type of $N$ the associated type. Since $\Delta^{\top}$ is a neutral element for $\sqcap$, then $\Delta^{\top}$ disappears in the bottom of the rule. The case for $n=0$ resembles the rules (drop) and/or ( $K$-cut) in [43] and was used to present the two cases, $n=0$ and $n \neq 0$ in a uniform way. In the rule (Weak) the choice of the type of $x$ is $T$, since this corresponds to a variable which does not occur anywhere in $M$. The remaining rules, namely $(A x)$ and $\left(\rightarrow_{I}\right)$ are traditional, i.e. they are the same as in the simply typed $\lambda$-calculus. Notice however that the type of the variable in $(A x)$ is a strict type.

Lemma 8 (Domain Correspondence for $\lambda_{\circledR} \cap$ ). Let $\Gamma \vdash M: \sigma$ be a typing judgment. Then $x \in \operatorname{Dom}(\Gamma)$ if and only if $x \in F v(M)$.

Proof. The rules of Figure 5 belong to three categories.

1. The rules that introduce a variable, namely (Ax), (Cont) and (Weak). One
sees that the variable is introduced in the environment if and only it is introduced in the term as a free variable.
2. The rules that remove variables, namely $\left(\rightarrow_{I}\right)$ and (Cont). One sees that the variables are removed from the environment if and only if they are removed from the term as a free variable.
3. The rule that does not introduce and does not remove a variable; namely $\left(\rightarrow_{E}\right)$.

Notice that (Cont) introduces and removes variables.
The Generation Lemma makes somewhat more precise the Domain Correspondence Lemma.

Lemma 9 (Generation lemma for $\lambda_{\circledR} \cap$ ).
(i) $\Gamma \vdash \lambda x . M: \tau$ iff there exist $\alpha$ and $\sigma$ such that $\tau \equiv \alpha \rightarrow \sigma$ and $\Gamma, x: \alpha \vdash$ $M: \sigma$.
(ii) $\Gamma \vdash M N: \sigma$ iff there exist $\Delta_{j}$ and $\tau_{j}, j=0, \ldots, n$ such that $\Delta_{j} \vdash N: \tau_{j}$ and $\Gamma^{\prime} \vdash M: \cap_{i}^{n} \tau_{i} \rightarrow \sigma$, moreover $\Gamma=\Gamma^{\prime}, \Delta_{0}^{\top} \sqcap \Delta_{1} \sqcap \ldots \sqcap \Delta_{n}$.
(iii) $\Gamma \vdash z<_{y}^{x} M: \sigma$ iff there exist $\Gamma^{\prime}, \alpha, \beta$ such that $\Gamma=\Gamma^{\prime}, z: \alpha \cap \beta$ and $\Gamma^{\prime}, x: \alpha, y: \beta \vdash M: \sigma$.
(iv) $\quad \Gamma \vdash x \odot M: \sigma$ iff $\Gamma=\Gamma^{\prime}, x: \top$ and $\Gamma^{\prime} \vdash M: \sigma$.

Proof. The proof is straightforward since all the rules are syntax directed.
The proposed system satisfies the following properties.
Lemma 10 (Substitution lemma for $\lambda_{\circledR} \cap$ ). If $\Gamma, x: \cap_{i}^{n} \tau_{i} \vdash M: \sigma$ and for all $j \in\{0, \ldots, n\}, \Delta_{j} \vdash N: \tau_{j}$, then $\Gamma, \Delta_{0}^{\top} \sqcap \Delta_{1} \sqcap \ldots \sqcap \Delta_{n} \vdash M[N / x]: \sigma$.

Proof. The proof is by induction on the structure of the term $M$. We only show the interesting cases.

- Base case $M=x$. By the axiom $x: \tau \vdash x: \tau$ where $\tau=\cap_{i}^{1} \tau_{i}$, i.e. $n=1$, hence the second assumption is $\Delta \vdash N: \tau$ which proves the case since $N \triangleq x[N / x]$.
- $M=x \odot P$. Now we assume $\Gamma, x: \cap_{i}^{0} \tau_{i} \vdash x \odot P: \sigma$ and $\Delta_{i} \vdash N: \tau_{i}$ for all $i \in\{0, \ldots, 0\}$, in other words $\Gamma, x: \top \vdash x \odot P: \sigma$ and $\Delta_{0} \vdash N: \tau_{0}$ (i.e. $N$ is typeable). By Generation lemma $9(i v)$ we get $\Gamma \vdash P: \sigma$. Since $\operatorname{Dom}\left(\Delta_{0}\right)=$ $F v(N)$ by applying the (Weak) rule multiple times we get $\Gamma, \Delta_{0}^{\top} \vdash F v(N) \odot$ $P \vdash \sigma$ which is exactly what we want to prove.
- $M=x<_{x_{2}}^{x_{1}} P$. From $\Gamma, x: \cap_{i}^{n} \tau_{i} \vdash x<_{x_{2}}^{x_{1}} P: \sigma$, by Generation lemma 9 (iii) we get that $\cap_{i}^{n} \tau_{i}=\cap_{i=1}^{m} \tau_{i} \cap \cap_{i=m+1}^{n} \tau_{i}$ for some $m<n$ and $\Gamma, x_{1}: \cap_{i}^{m} \tau_{i}, x_{2}$ : $\cap_{i=m+1}^{n} \tau_{i} \vdash P: \sigma$. From the other assumption $\Delta_{j} \vdash N: \tau_{j}$ for all $j \in\{0, \ldots, n\}$, by renaming the variables in $\Delta_{j}$ (i.e. the free variables of $N$ ) we get two different sets of sequents: $\Delta_{j}^{\prime} \vdash N_{1}: \tau_{j}$ and $\Delta_{j}^{\prime \prime} \vdash N_{2}: \tau_{j}$. By applying IH twice, we get $\Gamma, \Delta_{0}^{\prime \top} \sqcap \Delta_{1}^{\prime} \sqcap \ldots \sqcap \Delta_{m}^{\prime}, \Delta^{\prime \prime \top}{ }_{0}^{\top} \sqcap \Delta_{m+1}^{\prime \prime} \sqcap \ldots \sqcap \Delta_{n}^{\prime \prime} \vdash\left(P\left[N_{1} / x_{1}\right]\right)\left[N_{2} / x_{2}\right]: \sigma$. Now, we apply the definition of the parallel substitution, and perform contraction on all pairs of corresponding (i.e. obtained by the renaming of the same variable) elements of $\Delta_{l}^{\prime}$ and $\Delta_{k}^{\prime \prime}$ by introducing again the original names of the free variables of $N$ from $\Delta_{j}$ and finally get what we need:

Proposition 11 (Subject reduction and equivalence). For every $\lambda_{\circledR}$-term M: if $\Gamma \vdash M: \sigma$ and $M \rightarrow M^{\prime}$ or $M \equiv M^{\prime}$, then $\Gamma \vdash M^{\prime}: \sigma$.

Proof. The proof is done by the case analysis on the applied reduction. Since the property is stable by context, we can without loss of generality assume that the reduction takes place at the outermost position of the term. Here we just show several cases. We will use GL as an abbreviation for Generation lemma 9.

- Case $(\beta)$ : Let $\Gamma \vdash(\lambda x . M) N$ : $\sigma$. We want to show that $\Gamma \vdash M[N / x]: \sigma$. From $\Gamma \vdash(\lambda x . M) N: \sigma$ and from GL(ii) it follows that $\Gamma=\Gamma^{\prime}, \Delta_{0}^{\top} \sqcap \Delta_{1} \sqcap \ldots \sqcap \Delta_{n}$, and that there is a type $\cap_{j=0}^{n} \tau_{j}$ such that for all $j=0, \ldots, n, \Delta_{j} \vdash N: \tau_{j}$, and $\Gamma^{\prime} \vdash \lambda x . M: \cap_{i}^{n} \tau_{i} \rightarrow \sigma$. Further, by GL(i) we have that $\Gamma^{\prime}, x: \cap_{i}^{n} \tau_{i} \vdash$ $M: \sigma$. Now, all the assumptions of Substitution lemma 10 hold, yielding $\Gamma^{\prime}, \Delta_{0}^{\top} \sqcap \Delta_{1} \sqcap \ldots \sqcap \Delta_{n} \vdash M[N / x]: \sigma$ which is exactly what we need, since $\Gamma=\Gamma^{\prime}, \Delta_{0}^{\top} \sqcap \Delta_{1} \sqcap \ldots \sqcap \Delta_{n}$.
- Case $\left(\gamma \omega_{2}\right)$ : Let $\Gamma \vdash x<_{x_{2}}^{x_{1}} x_{1} \odot M: \sigma$. We show now that $\Gamma \vdash M\left[x / x_{2}\right]: \sigma$. From the first sequent by GL(iii) we have that $\Gamma=\Gamma^{\prime}, x: \alpha \cap \beta$ and $\Gamma^{\prime}, x_{1}$ : $\alpha, x_{2}: \beta \vdash x_{1} \odot M: \sigma$. Further, by GL(iv) we conclude that $\alpha \equiv \top, x$ : $T \cap \beta \equiv \beta$ and $\Gamma^{\prime}, x_{2}: \beta \vdash M: \sigma$. Since $\beta=\cap_{i}^{n} \tau_{i}$ for some $n \geq 0$, by applying Substitution lemma 10 to $\Gamma^{\prime}, x_{2}: \beta \vdash M: \sigma$ and $x: \tau_{j} \vdash x: \tau_{j}, j=0, \ldots, n$ we get $\Gamma \vdash M\left[x / x_{2}\right]: \sigma$.
- The other rules are easy since they do not essentially change the structure of the term.

Due to this property, equivalent terms have the same type.

### 1.3. Typeability $\Rightarrow S N$ in $\lambda_{\circledR} \cap$

In various type assignment systems, the reducibility method can be used to prove many reduction properties of typeable terms. It was first introduced by Tait [60] for proving the strong normalisation of simply typed $\lambda$-calculus, and developed further to prove strong normalisation of various calculi in [61, 31, $42,26,29]$, confluence (the Church-Rosser property) of $\beta \eta$-reduction in [41, 59, $45,46,29$ ] and to characterise certain classes of $\lambda$-terms such as strongly normalising, normalising, head normalising, and weak head normalising terms (and their persistent versions) by their typeability in various intersection type systems in $[24,18,16,17]$.

The main idea of the reducibility method is to interpret types by suitable sets of lambda terms which satisfy some realizability properties and prove the soundness of type assignment with respect to these interpretations. A consequence of soundness is that every typeable term belongs to the interpretation of its type, hence satisfying a desired reduction property.

In the remainder of the paper we consider $\Lambda_{\circledR}$ as the applicative structure whose domain are $\lambda_{\circledR}$-terms and where the application is just the application of $\lambda_{\circledR}$-terms. The set of strongly normalizing terms is defined as the smallest subset of $\Lambda_{\circledR}$ such that:

Definition 13. The type interpretation $\llbracket[-]:$ Types $\rightarrow 2^{\Lambda ®}$ is defined by:
(I1) $\llbracket p \rrbracket=\mathcal{S N}$, where $p$ is a type atom;
(I2) $[[\alpha \rightarrow \sigma]]=[[\alpha]] \longrightarrow \llbracket \sigma \rrbracket$;
(I3) $\left[\left\lceil\cap_{i}^{n} \sigma_{i}\right]\right]=\cap_{i}^{n}\left[\llbracket \sigma_{i}\right]$ and $\left[\cap_{i}^{0} \sigma_{i}\right]=\mathcal{S} \mathcal{N}$.

Next, we introduce the notions of variable property, reduction property, expansion property, weakening property and contraction property. Variable property and expansion property correspond to the saturation property given in [6], whereas reduction property corresponds to the property CR 2 in Chapter 6 of [33]. To this aim we will use the following notation: recall that $\mathbb{B}$ denotes the set of reductions given in Figure 2. If $\mu \in ®$, then redex ${ }_{\mu}^{\varsigma}$ denotes a redex, that is a term which is an instance by the meta-substitution $\varsigma$ of the left hand side of the reduction $\mu$. Whereas contr $r_{\mu}^{\varsigma}$ denotes the instance of the right hand side of the same reduction $\mu$ by the same meta-substitution $\varsigma .^{3}$

## Definition 14.

- A set $X \subseteq \Lambda_{\circledR}$ satisfies the variable property, notation $\operatorname{VAR}(X)$, if $X$ contains all the terms of the form $x M_{1} \ldots M_{n}$ for $M_{i} \in \mathcal{S N}$.
- A set $\mathcal{X} \subseteq \Lambda_{\circledR}$ satisfies the reduction property, notation $\operatorname{RED}(X)$, if $X$ is stable by reduction, in other words $M \in \mathcal{X}$ and $M \rightarrow M^{\prime}$ imply $M^{\prime} \in \mathcal{X}$.
- A set $X \subseteq \Lambda_{\circledR}$ satisfies the expansion property, notation $\operatorname{EXP}_{\mu}(X)$ where $\mu$ is a rule in $\left(\Omega, \mathrm{if}^{4}\right.$ :

- A set $X \subseteq \Lambda_{\circledR}$ satisfies the weakening property, notation $\operatorname{WEAK}(X)$ if:

- A set $X \subseteq \Lambda_{\circledR}$ satisfies the contraction property, notation $\operatorname{CONT}(X)$ if:

[^3]Remark. In the previous definition (Definition 14) it is not necessary to explicitly write the conditions about free variables since we work with $\lambda_{\circledR}$-terms.

Definition 15 (®-Saturated set). A set $X \subseteq \Lambda_{\circledR}$ is called $\circledR$ (®saturated, if

- $X \subseteq S \mathcal{N}$ and
- $X$ satisfies the variable, reduction, expansion, weakening and contraction properties.

Proposition 16. Let $\mathcal{M}, \mathcal{N} \subseteq \Lambda_{\mathbb{B}}$.
(i) $\mathcal{S N}$ is $®$-saturated.
(ii) If $\mathcal{M}$ and $\mathcal{N}$ are $\circledR$-saturated, then $\mathcal{M} \longrightarrow \mathcal{N}$ is $\circledR$-saturated.
(iii) If $\mathcal{M}$ and $\mathcal{N}$ are $\circledR$-saturated, then $\mathcal{M} \cap \mathcal{N}$ is $®$-saturated.
(iv) For all types $\varphi \in$ Types, $[\rceil]$ is $®$-saturated.

Proof. (i)

- $\mathcal{S N} \subseteq \mathcal{S N}, \operatorname{VAR}(\mathcal{S N})$ and $\operatorname{RED}(\mathcal{S N})$ trivially hold.
- $\operatorname{EXP}_{\beta}(\mathcal{S N})$. Suppose that $M[N / x] M_{1} \ldots M_{n} \in \mathcal{S N}$ and $M_{1}, \ldots, M_{n} \in \mathcal{S N}$. Since $M[N / x]$ is a subterm of a term in $\mathcal{S N}$, we know that $M \in \mathcal{S N}$. Also, since $M[N / x] \in \mathcal{S} \mathcal{N}$ and $M$ is linear, $N \in \mathcal{S} \mathcal{N}$. By assumption, $M_{1}, \ldots, M_{n} \in$ $\mathcal{S N}$, so the reductions inside of these terms terminate. After finitely many reduction steps, we obtain $(\lambda x . M) N M_{1} \ldots M_{n} \rightarrow \ldots \rightarrow\left(\lambda x . M^{\prime}\right) N^{\prime} M_{1}^{\prime} \ldots M_{n}^{\prime}$ where $M \rightarrow M^{\prime}, N \rightarrow N^{\prime}, M_{1} \rightarrow M_{1}^{\prime}, \ldots, M_{n} \rightarrow M_{n}^{\prime}$. After contracting $\left(\lambda x . M^{\prime}\right) N^{\prime} M_{1}^{\prime} \ldots M_{n}^{\prime}$ to $M^{\prime}\left[N^{\prime} / x\right] M_{1}^{\prime} \ldots M_{n}^{\prime}$, we obtain a reduct of $M[N / x] M_{1} \ldots M_{n} \in \mathcal{S X}$. Hence, $(\lambda x . M) N M_{1} \ldots M_{n} \in \mathcal{S} \mathcal{N}$.
- $\operatorname{EXP}_{\mu}(\mathcal{S N})$. Analogous to $\operatorname{EXP}_{\beta}(\mathcal{S N})$.
- $\operatorname{WEAK}(\mathcal{S N})$. Suppose that $M \in \mathcal{S N}$ and $x \notin F v(M)$. Then trivially $x \odot M \in$ $\mathcal{S N}$, since no new redexes are formed.
- $\operatorname{CONT}(\mathcal{S N})$. Suppose that $M \in \mathcal{S N}, y \neq z, y, z \in F v(M), x \notin F v(M) \backslash$ $\{y, z\}$. We prove $x<_{z}^{y} M \in \mathcal{S} \mathcal{N}$ by induction on the structure of $M$.
- $M=\lambda w . N$. Then $N \in \mathcal{S} \mathcal{N}$ and $x<_{z}^{y} M=x<_{z}^{y}(\lambda w \cdot N) \rightarrow_{\gamma_{1}} \lambda w \cdot x<_{z}^{y}$ $N \in \mathcal{S N}$, since $x<_{z}^{y} N \in \mathcal{S} \mathcal{N}$ by IH.
- $M=P Q$. Then $P, Q \in \mathcal{S N}$ and if $y, z \notin F v(Q), x<_{z}^{y} M=x<_{z}^{y}(P Q) \rightarrow \gamma_{2}$ $\left(x<_{z}^{y} P\right) Q \in \mathcal{S} \mathcal{N}$, since by IH $x<_{z}^{y} P \in \mathcal{S} \mathcal{N}$. The case of $\rightarrow_{\gamma_{3}}$ reduction is analogous.
- $M=w \odot N$. Then $x<_{z}^{y} M=x<{ }_{z}^{y}(w \odot N) \rightarrow \gamma \omega_{1} w \odot\left(x<_{z}^{y} N\right)$. By IH $x<_{z}^{y} N \in \mathcal{S} \mathcal{N}$ and $w \odot\left(x<_{z}^{y} N\right)$ does not introduce any new redexes.
- $M=y \odot N$. Then $x<_{z}^{y} M=x<_{z}^{y}(y \odot N) \rightarrow \gamma \omega_{2} N[x / z] \in \mathcal{S} \mathcal{N}$, since $N \in \mathcal{S} \mathcal{N}$ by IH.
(ii)

We need to show that $x M_{1} \ldots M_{n} \in$ $\mathcal{M} \longrightarrow \mathcal{N}$, i.e. $\forall N \in \mathscr{M}, x M_{1} \ldots M_{n} N \in \mathcal{N}$. This holds since by IH $\mathcal{M} \subseteq$ $\mathcal{S N}$ and $\mathcal{N}$ is $\circledR$-saturated, i.e. $\operatorname{VAR}(\mathcal{N})$ holds.
- $\operatorname{RED}(\mathscr{M} \rightarrow \mathcal{N})$. Let $M \in \mathscr{M} \longrightarrow \mathcal{N}$ and $M^{\prime}$ be such that $M \rightarrow M^{\prime}$ and let $N \in \mathscr{M}$. We know that $M N \in \mathcal{N}$ and $M N \rightarrow M^{\prime} N$. By $\mathrm{IH}, M^{\prime} N \in \mathcal{N}$ hence $M^{\prime} \in \mathscr{M} \longrightarrow \mathcal{N}$.
- $\operatorname{EXP}_{\beta}(\mathcal{M} \rightarrow \mathcal{N})$. Suppose that $M[N / x] M_{1} \ldots M_{n} \in \mathcal{M} \longrightarrow \mathcal{N}$ and $M_{1}, \ldots$, $M_{n} \in \mathcal{S} \mathcal{N}$. This means that for all $P \in \mathcal{M}, M[N / x] M_{1} \ldots M_{n} P \in \mathcal{N}$. But $\mathcal{N}$ is $®$-saturated, so $\operatorname{EXP}_{\beta}(\mathcal{N})$ holds and we have that for all $P \in \mathcal{N}$, $(\lambda x . M) N M_{1} \ldots M_{n} P \in \mathcal{N}$. This means that $(\lambda x . M) N M_{1} \ldots M_{n} \in \mathcal{M} \longrightarrow \mathcal{N}$.
- $\operatorname{EXP}_{\mu}(\mathcal{M} \longrightarrow \mathcal{N})$. Analogous to $\operatorname{EXP}_{\beta}(\mathscr{M} \longrightarrow \mathcal{N})$.
- $\operatorname{WEAK}(\mathcal{M} \longrightarrow \mathcal{N})$. Suppose that $M \in \mathcal{M} \longrightarrow \mathcal{N}$ and $x \notin F v(M)$. This means that for all $N \in \mathcal{M}, M N \in \mathcal{N}$. But $\mathcal{N}$ is $®$-saturated, i.e. WEAK $(\mathcal{N})$ holds, hence $x \odot(M N) \in \mathcal{N}$. Also $\operatorname{EXP}_{\omega_{2}}(\mathcal{N})$ holds so we obtain for all $N \in \mathscr{M},(x \odot M) N \in \mathcal{N}$, i.e $x \odot M \in \mathscr{M} \longrightarrow \mathcal{N}$.
- $\operatorname{CONT}(\mathcal{M} \longrightarrow \mathcal{N})$. Let $M \in \mathcal{M} \longrightarrow \mathcal{N}$. By reduction $\gamma_{2}$ and hence by $\operatorname{RED}(\mathcal{N})$ we have $\left(x<_{z}^{y} M\right) P \in \mathcal{N}$. Therefore $x<{ }_{z}^{y} M \in \mathcal{M} \rightarrow \mathcal{N}$.

- $\mathcal{M} \cap \mathcal{N} \subseteq \mathcal{S} \mathcal{N}$ is straightforward, since $M, N \subseteq \mathcal{S} \mathcal{N}$ by IH .
- $\operatorname{VAR}(\mathcal{M} \cap \mathcal{N})$. Since $\operatorname{VAR}(\mathscr{M})$ and $\operatorname{VAR}(\mathcal{N})$ hold, we have that $\forall M_{1}, \ldots$, $M_{n} \in \mathcal{S N}, n \geq 0: x M_{1} \ldots M_{n} \in \mathscr{M}$ and $x M_{1} \ldots M_{n} \in \mathcal{N}$. We deduce that $\forall M_{1}, \ldots, M_{n} \in \mathcal{S} \mathcal{N}, n \geq 0: x M_{1} \ldots M_{n} \in \mathscr{M} \cap \mathcal{N}$, i.e. $\operatorname{VAR}(\mathcal{M} \cap \mathcal{N})$ holds.
- $\operatorname{RED}(\mathscr{M} \cap \mathcal{N})$ is straightforward.
- $\operatorname{EXP}_{\beta}(\mathcal{M} \cap \mathfrak{N})$ and $\operatorname{EXP}_{\mu}(\mathcal{M} \cap \mathcal{N})$ are straightforward.
- $\operatorname{WEAK}(\mathcal{M} \cap \mathcal{N})$. Let $M \in \mathcal{M} \cap \mathcal{N}$ and $x \notin F v(M)$. Then $M \in \mathcal{M}$ and $M \in \mathcal{N}$. Since both $\mathcal{M}$ and $\mathcal{N}$ are $®$-saturated $\operatorname{WEAK}(\mathcal{M})$ and $\operatorname{WEAK}(\mathcal{N})$ hold, hence by $\mathrm{IH} x \odot M \in \mathscr{M}$ and $x \odot M \in \mathcal{N}$, i.e. $x \odot M \in \mathcal{M} \cap \mathcal{N}$.

Proof. Suppose $\Gamma \vdash M: \sigma$. By Proposition $21 \Gamma \models M: \alpha$. According to Definition 19(iii), this means that $(\forall \rho \models \Gamma) \quad \rho \models M: \sigma$. ## 1.4. $S N \Rightarrow$ Typeability in $\lambda_{\circledR} \cap$

We want to prove that if a $\lambda_{\circledR}$-term is SN , then it is typeable in the system $\lambda_{\circledR} \cap$. We proceed in two steps: 1) we show that all $\lambda_{\circledR}$-normal forms are typeable and 2 ) we prove the head subject expansion. First, let us observe the structure of the $\lambda_{\circledR}$-normal forms, given by the following abstract syntax:

Notice that it is necessary to distinguish normal forms $W_{n f}$ since the term $\lambda x . y \odot M_{n f}$ is not a normal form, since $\lambda x . y \odot M_{n f} \rightarrow \omega_{1} y \odot \lambda x . M_{n f}$.
Proposition 23. $\lambda_{\circledR}$-normal forms are typeable in the system $\lambda_{\circledR} \cap$.
Proof. By induction on the structure of $M_{n f}$ and $W_{n f}$.
Lemma 24 (Inverse substitution lemma). Let $\Gamma \vdash M[N / x]: \sigma$ and $N$ typeable. Proposition 25 (Head subject expansion). For every $\lambda_{\circledR}$-term $M$ : if $M \rightarrow M^{\prime}, M$ is a contracted redex and $\Gamma \vdash M^{\prime}: \sigma$, then $\Gamma \vdash M: \sigma$, provided that if $M \equiv$ $(\lambda x . N) P \rightarrow_{\beta} N[P / x] \equiv M^{\prime}, P$ is typeable.
Proof. By case study according to the applied reduction.
Theorem 26 ( $\mathrm{SN} \Rightarrow$ typeability). All strongly normalising $\lambda_{\circledR}$-terms are typeable in the $\lambda_{\circledR} \cap$ system.

Proof. The proof is by induction on the length of the longest reduction path out of a strongly normalising term $M$, with a subinduction on the size of $M$.

- If $M$ is a normal form, then $M$ is typeable by Proposition 23.
- If $M$ is itself a redex, let $M^{\prime}$ be the term obtained by contracting the redex $M . M^{\prime}$ is also strongly normalising, hence by IH it is typeable. Then $M$ is typeable, by Proposition 25. Notice that, if $M \equiv(\lambda x . N) P \rightarrow_{\beta} N[P / x] \equiv M^{\prime}$, then, by IH, $P$ is typeable, since the length of the longest reduction path out of $P$ is smaller than that of $M$, and the size of $P$ is smaller than the size of $M$.
- Next, suppose that $M$ is not itself a redex nor a normal form. Then $M$ is of one of the following forms: $\lambda x . N, \lambda x . x \odot N, x M_{1} \ldots M_{n}, x \odot N$, or $x<_{x_{2}}^{x_{1}} N P, x_{1} \in F v(N), x_{2} \in F v(P)$ (where $M_{1}, \ldots, M_{n}, N$, and $N P$ are not normal forms). $M_{1}, \ldots, M_{n}$ and $N P$ are typeable by IH , as subterms of $M$. Then, it is easy to build the typing for $M$. For instance, let us consider the case $x<_{x_{2}}^{x_{1}} N P$ with $x_{1} \in F v(N), x_{2} \in F v(P)$. By induction $N P$ is typeable, hence $N$ is typeable with say $\Gamma, x_{1}: \beta \vdash N: \cap_{i}^{n} \tau_{i} \rightarrow \sigma$ and $P$ is typeable with say $\Delta_{j}, x_{2}: \gamma_{j} \vdash P: \tau_{j}$, for all $j=0, \ldots, n$. Then using the rule $(E \rightarrow)$ we obtain $\Gamma, \Delta_{0}^{\top} \sqcap \Delta_{1} \sqcap \ldots \sqcap \Delta_{n}, x_{1}: \beta, x_{2}: \cap_{i}^{n} \gamma_{i} \vdash N P: \sigma$. Finally, the rule (Cont) yields $\Gamma, \Delta_{0}^{\top} \sqcap \Delta_{1} \sqcap \ldots \sqcap \Delta_{n}, x: \beta \cap\left(\cap_{i}^{n} \gamma_{i}\right) \vdash x<_{x_{2}}^{x_{1}} N P: \sigma$.

Finally, we can give a characterisation of strong normalisation in $\lambda_{\circledR}$-calculus.
Theorem 27. In $\lambda_{\circledR}$-calculus, the term $M$ is strongly normalising if and only if it is typeable in $\lambda_{\circledR} \cap$.

Proof. Immediate consequence of Theorems 22 and 26.

## 2. Intersection types for the sequent resource control lambda calculus $\lambda_{\mathbb{B}}^{\mathrm{Gtz}}$

In this section we focus on the sequent resource control lambda calculus $\lambda_{\mathbb{®}}{ }_{\mathbb{R}}$. First we revisit its syntax and operational semantics; further we introduce an intersection type assignment system and finally we prove that typeability in the proposed system completely characterises the set of strongly normalising $\lambda_{\mathbb{B}}^{\mathrm{Gtz}}-$ expressions.

### 2.1. Resource control sequent lambda calculus $\lambda_{\circledR}^{\mathrm{Gtz}}$

The resource control lambda Gentzen calculus $\lambda_{\mathbb{B}}^{\mathrm{Gtz}}$ is derived from the $\lambda^{\mathrm{Gtz}}$ calculus (more precisely its confluent sub-calculus $\lambda_{V}^{\mathrm{Gtz}}$ ) by adding the explicit operators for weakening and contraction. It is proposed in [28]. The abstract syntax of $\lambda_{\mathbb{®}}^{G t z}$ pre-expressions is the following:

where $x$ ranges over a denumerable set of term variables.
A pre-value can be a variable, an abstraction, a weakening or a contraction; a pre-term is either a value or a cut (an application). A pre-context is one of the following: a selection, a context constructor (usually called cons), a weakening on pre-context or a contraction on a pre-context. Pre-terms and pre-contexts are together referred to as the pre-expressions and will be ranged over by $E$. Precontexts $x \odot c$ and $x<_{x_{2}}^{x_{1}} c$ behave exactly like corresponding pre-terms $x \odot f$ and $x<_{x_{2}}^{x_{1}} f$ in the untyped calculus, so they will mostly not be treated separately. The set of free variables of a pre-expression is defined analogously to the free variables in $\lambda_{\circledR}$-calculus with the following additions:

Like in $\lambda_{\mathbb{B}}$-calculus, the set of $\lambda_{\mathbb{B}}^{\mathrm{Gtz}}$-expressions (namely values, terms and contexts), denoted by $\Lambda_{\overparen{®}}^{\mathrm{Gtz}} \cup \Lambda_{\overparen{®}, C}^{\mathrm{Gtz}}$, is a subset of the set of pre-expressions, defined in Figure 6. Values are denoted by $T$, terms by $t, u, v \ldots$, contexts by $k, k^{\prime}, \ldots$ and expressions by $e, e^{\prime}$.

The computation over the set of $\lambda_{\mathbb{\circledR}}^{G t z}$-expressions reflects the cut-elimination process. Four groups of reductions in $\lambda_{\Omega}^{\mathrm{Gtz}}$-calculus are given in Figure 7 .

The first group consists of $\beta_{\mathrm{g}}, \pi, \sigma$ and $\mu$ reductions from the $\lambda^{\mathrm{Gtz}}$. New reductions are added to deal with explicit contraction ( $\gamma$ reductions) and weakening ( $\omega$ reductions). The groups of $\gamma$ and $\omega$ reductions consist of rules that perform propagation of contraction into the expression and extraction of weakening out of the expression. This discipline allows us to optimize the computation by delaying the duplication of terms on the one hand, and by performing the erasure of terms as soon as possible on the other. The equivalencies in $\lambda_{\mathbb{B}} \mathrm{Gtz}$ are the ones given in Figure 4, except for the fact that they refer to $\lambda_{\circledR}^{G \text { tz }}$-expressions.

The meta-substitution $t[u / x]$ is defined as in Figure 3 with the following addi-

### 2.2. Intersection types for $\lambda_{\circledR}^{G t z}$

The type assignment system $\lambda_{\mathbb{B}}^{\mathrm{Gtz}} \cap$ that assigns strict types to $\lambda_{\mathbb{\circledR}}^{\mathrm{Gtz}}$-expressions is given in Figure 8. Due to the sequent flavour of the $\lambda_{\mathbb{Q}}^{\mathrm{Gtz}}$-calculus, here we distinguish two sorts of type assignments:

- $\Gamma \vdash t: \sigma$ for typing a term and
$-\Gamma ; \beta \vdash k: \sigma$, a type assignment with a stoup, for typing a context.
A stoup is a place for the last formula in the antecedent, after the semi-colon. The formula in the stoup is the place where computation will continue.

The syntax of types and the related definitions are the same as in $\lambda_{\circledR} \cap$. The $\lambda_{\mathbb{®}}^{\mathrm{Gtz}} \cap$ system is also syntax-directed i.e. the intersection is incorporated into already existing rules of the simply-typed system. In the style of sequent calculus, left intersection introduction is managed by the contraction rules $\left(\right.$ Cont $\left._{t}\right)$ and $\left(\right.$ Cont $\left._{k}\right)$, whereas the right intersection introduction is performed by the cut rule (Cut) and left arrow introduction rule $\left(\rightarrow_{L}\right)$. In these two rules $\operatorname{Dom}\left(\Gamma_{1}\right)=\ldots=$ $\operatorname{Dom}\left(\Gamma_{n}\right)$. The role of $\Gamma_{0}^{\top}$ has been already explained in subsection 1.2.

Proof. By case analysis on the applied reduction, using Lemmas 30 and 31 for the cases of $(\sigma)$ and $(\pi)$ rule, respectively.

### 2.3. Typeability $\Rightarrow S N$ in $\lambda_{\mathbb{B}}^{\mathrm{Gtz}} \cap$

In this section, we prove the strong normalisation of the $\lambda_{\mathbb{®}} \mathrm{Gtz}$-calculus with intersection types. The termination is proved by showing that the reduction on the set $\Lambda_{\overparen{®}}^{\mathrm{Gtz}} \cup \Lambda_{\mathbb{®}, C}^{\mathrm{Gtz}}$ of the typeable $\lambda_{\mathbb{®}}^{\mathrm{Gtz}}$-expressions is included in a particular well-founded relation, which we define as the lexicographic product of three wellfounded component relations. The first one is based on the mapping of $\lambda_{\mathbb{®}}^{\mathrm{Gtz}}$ expressions into $\lambda_{\circledR}$-terms. We show that this mapping preserves types and that every $\lambda_{\circledR}^{G \mathrm{tz}}$-reduction can be simulated either by a $\lambda_{\circledR}$-reduction or by an equality and each $\lambda_{\mathbb{®}}^{\mathrm{Gtz}}$-equivalence can be simulated by an $\lambda_{\mathbb{B}}$-equivalence. The other two well-founded orders are based on the introduction of quantities designed to decrease a global measure associated with specific $\lambda_{\mathbb{R}}^{G t z}$-expressions during the computation.

Definition 34. The mapping $L\rfloor: \Lambda_{\mathbb{®}}^{\mathrm{Gtz}} \rightarrow \Lambda_{\mathbb{®}}$ is defined together with the auxiliary mapping $\left\rfloor_{\mathrm{k}}: \Lambda_{\mathbb{Q}, C}^{\mathrm{Gtz}} \rightarrow\left(\Lambda_{\circledR} \rightarrow \Lambda_{\mathbb{B}}\right)\right.$ in the following way:

Since the set of equivalences of the two calculi coincide, they are trivially preserved. If one wants to prove that there is no infinite sequence of $\lambda_{\mathbb{R}}^{\mathrm{Gtz}}$-reductions one has to prove that there cannot exist an infinite sequence of $\lambda_{\circledR}^{\mathrm{Gtz}}$-reductions which are all interpreted as equalities. To prove this, one shows that if a term is reduced with such a $\lambda_{\AA}^{\mathrm{Gtz}}{ }_{-}$ reduction, it is reduced for another order that forbids infinite decreasing chains. This order is itself composed of several orders, free of infinite decreasing chains (Definition 45).

By Proposition 36 typeability is preserved by the interpretation $\left\rfloor\right.$ and $\rightarrow_{\lambda_{\circledR}}$ is strongly normalising (i.e., well-founded) on $\Lambda_{\circledR} \cap$ (Section 1.3), hence $>_{\lambda_{\circledR}}$ is well-founded on $\Lambda_{\circledR}^{G \mathrm{Gtz}} \cap$. Similarly, $>_{c}$ and $>_{w}$ are well-founded, as they are based on interpretations into the well-founded relation $>$ on the set $\mathbb{N}$ of natural numbers.

## 2.4. $S N \Rightarrow$ Typeability in $\lambda_{\circledR}^{\mathrm{Gtz}} \cap$

Now, we want to prove that if a $\lambda_{\mathbb{®}}^{\mathrm{Gtz}}$-term is SN, then it is typeable in the system $\lambda_{\circledR}^{G t z} \cap$. We follow the procedure used in Section 1.4. The proofs are similar to the ones in Section 1.4.

The abstract syntax of $\lambda_{(®)}^{\mathrm{Gtz}}$-normal forms is the following:

We use $e_{n f}$ for any $\lambda_{\mathbb{®}}^{\mathrm{Gtz}}$-expression in the normal form.
Proposition 49. $\lambda_{\circledR}^{\mathrm{Gtz}}$-normal forms are typeable in the system $\lambda_{\circledR}^{\mathrm{Gtz}} \cap$.
Proof. By mutual induction on the structure of $t_{n f}, k_{n f}$ and $w_{n f}$.
The following two lemmas explain the behavior of the meta operators [/] and @ during expansion.

Lemma 50 (Inverse substitution lemma).
(i) Let $\Gamma \vdash t[u / x]: \sigma$ and $u$ typeable. Proof. By mutual induction on the structure of terms and contexts.
Lemma 51 (Inverse append lemma). If $\Gamma ; \alpha \vdash k @ k^{\prime}: \sigma$, then there are $\Delta_{j}$ and $\tau_{j}, j=0, \ldots, n$ such that $\Delta_{j} ; \alpha \vdash k: \tau_{j}$ and $\Gamma^{\prime} ; \cap_{i}^{n} \tau_{i} \vdash k^{\prime}: \sigma$, where $\Gamma=\Gamma^{\prime}, \Delta_{0}^{\top} \sqcap$ $\Delta_{1} \sqcap \ldots \sqcap \Delta_{n}$.

Proof. By induction on the structure of the context $k$.
Now we prove that the type of a term is preserved during the expansion.
Proposition 52 (Head subject expansion). For every $\lambda_{\mathbb{\circledR}}^{\mathrm{Gtz}}$-term $t$ : if $t \rightarrow t^{\prime}, t$ is contracted redex and $\Gamma \vdash t^{\prime}: \sigma$, then $\Gamma \vdash t: \sigma$.

Proof. By case study according to the applied reduction.
Theorem 53 ( $\mathrm{SN} \Rightarrow$ typeability). All strongly normalising $\lambda_{\mathbb{®}}^{\mathrm{Gtz}}$ terms are typeable in the $\lambda_{\mathbb{®}}^{\mathrm{Gtz}} \cap$ system.
Proof. Analogous to the proof of Theorem 26.
Now we give a characterisation of strong normalisation in $\lambda_{\mathbb{R}}^{\mathrm{Gtz}}$-calculus.
Theorem 54. In $\lambda_{\mathbb{R}}^{\mathrm{Gtz}}$-calculus, the term $t$ is strongly normalising if and only if it is typeable in $\lambda_{\mathbb{B}}^{\mathrm{Gtz}} \cap$.
Proof. Immediate consequence of Theorems 48 and 53.

## 3. Intersection types for the resource control lambda calculus with explicit substitution $\lambda_{\circledR}^{\times}$

### 3.1. Resource control lambda calculus with explicit substitution $\lambda_{\circledR} \times$

The resource control lambda calculus with explicit substitution $\lambda_{\mathbb{R}} \times$, is an extension of the $\lambda_{x}$-calculus with explicit operators for weakening and contraction. It corresponds to the $\lambda \mid x r-c a l c u l u s$ of Kesner and Lengrand, proposed in [36], and also represents a vertex of "the prismoid of resources".

The pre-terms of $\lambda_{\mathbb{B}}^{\times}$-calculus are given by the following abstract syntax:

The only point of difference with respect to $\lambda_{\circledR}$-calculus is the operator of explicit substitution $\langle:=\rangle$.

The set of free variables of a pre-term $f$, denoted by $F v(f)$, is defined as follows:

In $f\langle x:=g\rangle$, the substitution binds the variable $x$ in $f$.
The set of $\lambda_{\mathbb{B}}^{\times}$-terms, denoted by $\Lambda_{\mathbb{B}}^{\times}$and ranged over by $M, N, P, M_{1}, \ldots$. is a subset of the set of pre-terms, defined by the rules in Figure 9.

The notion of terms corresponds to the notion of linear terms in [36]. The reduction rules of $\lambda_{\circledR} \times$-calculus are presented in Figure 10. In the $\lambda_{\mathbb{R}}^{\times}$, one works modulo equivalencies given in Figure 11.

### 3.2. Intersection types for $\lambda_{\mathbb{B}} \times$

In this subsection we introduce intersection type assignment system which assigns strict types to $\lambda_{\circledR}^{\times}$-terms. The system is syntax-directed, hence significantly different from the one proposed in [43].

The syntax of types and the definitions of type assignment, basis, etc. are the same as in the case of the system $\lambda_{\circledR} \cap$. The type assignment system $\lambda_{\circledR}^{\times} \cap$ is given in Figure 12. The only difference with respect to the $\lambda_{\circledR} \cap$ is the presence of one new type assignment rule, namely (Subst) for typing the explicit substitution.

The proposed system also satisfies preservation of free variables, bases intersection and subject reduction and equivalence.

### 3.3. Typeability $\Rightarrow S N$ in $\lambda_{\overparen{\circledR}} \times \cap$

Now we prove the strong normalisation of the $\lambda_{\mathbb{R}} \times$-calculus with intersection types. We follow the procedure established for proving the strong normalisation of the system $\lambda_{\mathbb{Q}}^{\mathrm{Gtz}} \cap$. In the sequel, we denote by $\Lambda_{\mathbb{®}}^{\times}$the set of $\lambda_{\mathbb{®}}^{\times}$-terms, and by $\Lambda_{\mathbb{®}}^{\times} \cap$ the set of $\lambda_{\mathbb{®}}^{\times}$-terms typeable in the system $\lambda_{\mathbb{®}}^{\times} \cap$.

Definition 56. The mapping $\left\rceil: \Lambda_{\mathbb{\circledR}}^{\times} \rightarrow \Lambda_{\circledR}\right.$ is defined in the following way:

Proof. The proposition is proved by induction on derivations. We distinguish cases according to the last typing rule used. Cases $(A x),\left(\rightarrow_{I}\right),\left(\rightarrow_{E}\right)$, (Weak) and (Cont) are trivial, because the intersection type assignment system of $\lambda_{\circledR}$ has exactly the same rules. The only interesting case is the rule (Subst). In that case, the derivation ends with the rule

We now show that each $\lambda_{\mathbb{®}}$-reduction step can be simulated through the encoding $\left\rceil\right.$, by a $\lambda_{\circledR}$-reduction or an equality.

Theorem 59 (Simulation of $\lambda_{\circledR} \times$-reduction and equivalence by $\lambda_{\circledR}$-reduction and equivalence).
(i) If a $\lambda_{\mathbb{R}}^{\times}$-term $M \rightarrow M^{\prime}$, then $\lceil M\rceil \rightarrow_{\lambda_{\circledR}}\left\lceil M^{\prime}\right\rceil$ or $\lceil M\rceil=\left\lceil M^{\prime}\right\rceil$.

[^4](ii) If a $\lambda_{\mathbb{B}}^{\times}-$term $M \equiv \lambda_{\circledR}^{\times} M^{\prime}$, then $\lceil M\rceil \equiv \lambda_{\circledR}\left\lceil M^{\prime}\right\rceil$ or $\lceil M\rceil=\left\lceil M^{\prime}\right\rceil$.

Proof. (i) Without losing generality, we prove the statement only for the outermost reductions. The rules $\gamma_{1}, \gamma_{2}, \gamma_{3}, \omega_{1}, \omega_{2}, \omega_{3}, \gamma \omega_{1}, \gamma \omega_{2}$ are simulated by the corresponding rules of $\lambda_{\circledR}$. The previous proposition shows that each $\lambda_{\mathbb{®}} \times$-reduction step is interpreted either by a $\lambda_{\circledR}$-reduction or by an equality. More precisely: $\beta_{\mathrm{x}}, \gamma_{1}, \gamma_{2}, \gamma_{3}, \omega_{1}, \omega_{2}, \omega_{3}$, $\gamma \omega_{1}$ and $\gamma \omega_{2}$ reductions are interpreted by $\lambda_{\circledR}$-reductions, $\sigma_{1}-\sigma_{8}$ reductions are interpreted by identities, while $\gamma_{4}$ and $\omega_{4}$ reductions are interpreted either by $\lambda_{\circledR}$-reductions or by $\lambda_{\circledR}$-equivalencies, depending on the structure of the term. In order to define a lexicografic product of orders that forbid infinite decreasing chains of $\lambda_{\circledR}^{\times}$-reductions, we use two measures defined on the set $\Lambda_{\circledR}^{\times}$, namely term complexity $\mathcal{T} \mathcal{C}(M)$ and interpretation $I(M)$ (based on multiplicity $\mathcal{M}(M)$ ), proposed in [36] and already used for proving the strong normalisation of the simply typed $\lambda \mid x r$-calculus. We give their definitions here.

Definition 60 (Multiplicity [36]). Given a free variable $x$ in a $\lambda_{\mathbb{R}} \times$-term $M$, the multiplicity of $x$ in $M$, written $\mathcal{M}_{x}(M)$, is defined by induction on terms as follows, supposing that $x \neq y, x \neq z, x \neq w$ :

The following proposition proves that the reduction relation on the set of typed $\lambda_{\circledR}^{\times}$-terms, $\Lambda_{\mathbb{R}}^{\times} \cap$, is included in the given lexicographic product $>_{x}$.
Proposition 65. For each $M \in \Lambda_{\mathbb{R}}^{\times}$: if $M \rightarrow M^{\prime}$, then $M>_{\times} M^{\prime}$.
Proof. The proof is by case analysis on the kind of reduction and the structure of $>_{x}$.
If $M \rightarrow M^{\prime}$ by $\beta_{x}, \gamma_{1}, \gamma_{2}, \gamma_{3}, \omega_{1}, \omega_{2}, \omega_{3}, \gamma \omega_{1}$ or $\gamma \omega_{2}$, reduction, then $M>_{\lambda_{@}^{\times}} M^{\prime}$ by Theorem 59.
If $M \rightarrow M^{\prime}$ by $\sigma_{1}, \sigma_{5}, \sigma_{7}$ or $\sigma_{8}$ then $M=\lambda_{\circledR \times} M^{\prime}$ by Theorem 59 , and $M>_{\mathcal{T}_{\mathcal{C}}} M^{\prime}$ by ([36], Lemma 3).
Finally, if $M \rightarrow M^{\prime}$ by $\sigma_{2}, \sigma_{3}, \sigma_{4}, \sigma_{6}, \gamma_{4}$ or $\omega_{4}$, then $M=\lambda_{\circledR} M^{\prime} M^{\prime}$ by Theorem 59 , $M=_{\mathcal{T}^{C}} M^{\prime}$ by ([36], Lemma 3) and $M>_{I} M^{\prime}$ by ([36], Lemma 4).
Theorem 66 (Strong normalization of $\lambda_{\circledR}^{\times} \cap$ ). Each term in $\Lambda_{\circledR}^{\times} \cap$ is $S N$.
Proof. The proof is analogous to the proof of Theorem 48.

## 3.4. $S N \Rightarrow$ Typeability in $\lambda_{\circledR}^{\times} \cap$

We finally prove that if a $\lambda_{\mathbb{R}}^{\times}$-term is SN , then it is typeable in the system $\lambda_{\mathbb{®}}^{\times} \cap$. Due to the definition of the $\lambda_{\mathbb{B}}^{\times}$-terms given in Figure 9, particularly $M\langle x:=N\rangle$ where $x \in F v(M)$ is required, as well as to the reductions $\left(\sigma_{1}-\sigma_{8}\right)$, the set of $\lambda_{\circledR}^{\times}$-normal forms coincide with the set of $\lambda_{\circledR}$-normal forms. This, combined with the fact that all type assignment rules from Figure 5 exist also in the $\lambda_{\mathbb{R}}^{\times} \cap$ system, has as a consequence the following proposition.

Proposition 67. $\lambda_{\mathbb{\circledR}}^{\times}$-normal forms are typeable in the system $\lambda_{\mathbb{®}} \cap$.
Proposition 68 (Head subject expansion). For every $\lambda_{\mathbb{R}} \times$-term $M$ : if $M \rightarrow M^{\prime}$, $M$ is contracted redex and $\Gamma \vdash M^{\prime}: \sigma$, then $\Gamma \vdash M: \sigma$, provided that if $M \equiv$ $(\lambda x . N) P \rightarrow_{\beta_{x}} N\langle x:=P\rangle \equiv M^{\prime}, P$ is typeable.

Proof. By the case study according to the applied reduction.
Theorem 69 ( $\mathrm{SN} \Rightarrow$ typeability). All strongly normalising $\lambda_{\mathbb{®}}$-terms are typeable in the $\lambda_{\mathbb{R}} \cap$ system.

Now we can give a characterisation of strong normalisation in $\lambda_{\mathbb{\circledR}}^{\times}$-calculus.
Theorem 70. In $\lambda_{\mathbb{\circledR}}^{\times}$-calculus, the term $M$ is strongly normalising if and only if it is typeable in $\lambda_{\circledR} \times$.

Proof. Immediate consequence of Theorems 66 and 69.

## 4. Conclusions

In this paper, we have proposed intersection type assignment systems for:

- resource control lambda calculus $\lambda_{\mathbb{B}}$, which corresponds to $\lambda_{\text {CW }}$ of [37];
- resource control sequent lambda calculus $\lambda_{\mathbb{®}}^{G t z}$ of [28] and
- resource control calculus with explicit substitution $\lambda_{\circledR} \times$ of [36].

The three intersection type assignment systems proposed here give a complete characterization of strongly normalizing terms for these three calculi. The strong normalisation of typeable resource control lambda terms is proved directly by an appropriate modification of the reducibility method, whereas the same property for resource control sequent lambda terms is proved by well-founded lexicographic order based on suitable embedding into the former calculus and the strong
normalisation of the calculus with explicit substitution is given by its interpretation in the resource control lambda calculus. This paper expands the range of the intersection type techniques and combines different methods in the strict types environment. It should be noticed that the strict control on the way variables are introduced determines the way terms are typed in a given environment. Basically, in a given environment no irrelevant intersection types are introduced. The flexibility on the choice of a type for a term, as it is used in rule $\left(\rightarrow_{E}\right)$ in Figure 5, comes essentially from the choice one has in invoking the axiom. Unlike the approach of introducing non-idempotent intersection types into the calculus with some kind of resource management [49], our intersection is idempotent. As a consequence, our type assignment system corresponds to full intuitionistic logic, while non-idempotent intersection type assignment systems correspond to intuitionistic linear logic.

The three presented calculi $\lambda_{\circledR}, \lambda_{\circledR}^{\mathrm{Gtz}}$ and $\lambda_{\mathbb{®}}^{\times}$are good candidates to investigate the computational content of substructural logics [58], both in natural deduction and sequent calculus. The motivation for these logics comes from philosophy (Relevant Logics), linguistics (Lambek Calculus) to computing (Linear Logic). Since the basic idea of resource control is to explicitly handle structural rules, the control operators could be used to handle the absence of (some) structural rules in substructural logics such as weakening, contraction, commutativity, associativity. This would be an interesting direction for further research. Another direction will involve the investigation of the use of intersection types, being a powerful means for building models of lambda calculus [7, 17], in constructing models for sequent lambda calculi. Finally, one may wonder how the strict control on the duplication and the erasure of variables influences the type reconstruction of terms [12,39].
